PARENT AGREEMENT

1. Every Parent/Guardian is encouraged to serve on the executive board or on a committee during the school year.
2. I understand that my child must be toilet trained before commencement of school.
3. I have completed the application form and enclosed one cheque for fifty dollars (\$50.00 which covers the registration fee and **one** of the following (please check off your preferred option):

pre-authorized payment form and a void cheque to cover monthly tuition (\$112.00 per month from September 2020 – May 2021). Please note that there is an additional \$0.35 charge per transaction

OR

one cheque for one-thousand eight dollars (\$1008.00) which covers monthly tuition from September 2020 – June 4, 2021 (112.00 per month x nine months)

[Please make cheques payable to Angus McKay Nursery School. No refunds are given for absent days, school in-service days, or normal holidays. (Christmas, Spring Break etc.) Should we receive NSF cheques, you will be responsible for all bank charges.]]

4. I give permission for my child to take part in activities and outings planned and supervised by the Angus McKay Nursery School staff.
5. Unless bus transportation is provided, I understand I must either drive my child or arrange transportation with another parent for my child on field trips as per safety guidelines under MPIC child restraints.
6. Should an accident, loss, damage or theft of any belongings occur, I release the Angus McKay Nursery School for any liabilities.

7. Withdrawals: I understand that should I withdraw my child after registration, the registration fee of fifty dollars (\$50.00) is **non-refundable**.

Should a child withdraw after the first day of nursery school, or throughout the year, notification must be given **three weeks in advance, in writing to the Vice-President** of the nursery school executive. The executive committee reviews all withdrawal cases and will respond in writing.

In order to cancel the pre-authorized payment agreement, Angus McKay Nursery School must receive written notice at least ten (10) business days prior to the next scheduled withdrawal due date. Please see the CAFT Authorization Terms & Conditions for more details.

8. In the case of the revoking of registration and involuntary withdrawal, due to breach of the contract and/or unsuitability of the program for the child or vice-versa, the following procedure will be followed:
- i) Verbal notification and discussion of requirements by an individual designated by the executive committee.
 - ii) Written notification.
 - ii) The matter will be brought before the executive committee. The decision will be binding.
9. To comply with Day Care Regulations and River East Transcona School Division policy, no nuts, peanuts, or peanut products will be allowed in the nursery school to ensure the safety for children with food allergies. Food substances containing nuts, peanuts and peanut products are also not allowed at nursery school functions involving the children. In September, you will be notified and expected to comply with other snack restrictions as per any other allergies affecting the current class.
10. I give permission for my child to be photographed and/or video-taped. The children's photos are used to put up on bulletin boards inside the classroom, when making crafts in class and for slide shows for special occasions (such as the Christmas concert and end of year celebration).
